## **Bylaws Committee**

This committee is established to review the Department Bylaws annually. The committee is empowered to review the Bylaws, and will decide on matters whether or not to recommend changes to the Bylaws, either proposed by the committee or by submission to the committee from the Department. The procedure is as follows: if after first review the committee members unanimously recommend no changes to the Department Bylaws, then the Chair may have the committee meet electronically via email communication for the duration of the appointment. Upon such time that a review for action is determined by the committee, then the committee shall convene to devise recommendations. Reports shall be filed as necessary, but minimally an annual report will be submitted to the Department Secretary by April 1, 2020. The committee shall expire at the 2020 Department Encampment. For our recent Encampment I had additional material prepared to deliver to the Department. However, in the interest of keeping the meeting moving along and to be as brief as possible, I curtailed many of my talking points. This Order will also serve to review and clarify my positions for the coming 2019-2020 term. My concepts were also included in my announcement letter for office that was released in February.

The first point I make is we (RI SUVCW) are a Department in good standing in the Order. Rhode Island SUVCW is extremely well represented at the National level. This is undeniably the result of most of the active Brothers in the Department, our Past Department Commanders, and especially the efforts of our Immediate Past Department Commander, Jamie McGuire.
